# UNIVERSITY OF TENNESSEE – BENEFITS AVAILABLE FOR RETIREES

Must meet these requirements for a Retiree ID and other Benefits associated with being a “retiree”. Benefits may differ depending on years of retirement creditable service and/or age.

## “Definition of a “Retiree”

A University of Tennessee retiree is an individual who, immediately prior to termination, has met the eligibility requirements for retirement of the State of Tennessee

(TCRS, ORP, JCRS). Those requirements are:

- A. Age 60 with at least 5 years of service
- B. Age 55 with at least 10 years of service
- C. Any age with 25 years of service
- D. CSRS and FERS has its own set of “Retiree” requirements

- \* 10 or more years of retirement creditable service
- \*\* Must have purchased tickets 10 continuous years prior to retirement
- \*\*\* 10 years of retirement creditable service with 3 years of coverage prior to retirement
- \*\*\*\* 15 years of retirement creditable service with the University of Tennessee
